
#### SCHOLARSHIP 2022

The Alabama Chapter of APCO started the APCO Scholarship in the year 2012 and the first scholarship of \$500 was awarded in 2013. The Alabama Chapter of APCO wanted to do something to assist our members and first responders with the cost of college and to allow their family members the benefit of a better education. To receive the scholarship you must be the son, daughter, granddaughter or grandson of a current Alabama APCO member and you must be either an entering freshman or returning full-time college student. ## 2023 Awards

#### **Communications Officer of the Year**

Awarded to *one* Telecommunicator who demonstrates the important nature of the job they perform by the level of service, skill and knowledge displayed on a daily basis. The recipient consistently goes above and beyond serving the general public, law enforcement, fire, ems, other agencies, his/her peers, and administrators.

#### **Communications Team/Communication Center of the Year**

Awarded to *two or more* Telecommunicators who demonstrate the important nature of the job they perform by the level of service, skill and knowledge displayed on a daily basis. **Communications** 

#### Trainer of the Year

Awarded to *one* certified or non-certified Training Officer who has had one or more successful trainees. This person must have great knowledge and understanding his/her field, charisma, a unique training style, innovative training style or individual training style that deserves recognition.

### Communications Executive Staff of the Year (Includes Training Coordinators/GIS/Support Staff/Operations/Managers/Directors/IT)

Awarded to *one* member of Executive Staff for any individual outstanding service deserving of recognition.

#### Line Supervisor of the Year

Awarded to *one* Shift Lead or Floor Supervisor who excels at the job he/she performs and effectively manages personnel in his/her agency. He/she must easily adapt to a changing environment balancing the needs of personnel, law enforcement, fire, ems, upper management, citizens and other agencies all the while upholding a respectable and professional attitude.

#### Award of Excellence

Awarded to *one* Telecommunicator who consistently exceeds expectations in emergency communications.

#### Lifesaver Award

Awarded to *one or a team of two* who Performed CPR, EMD or any other life-saving instructions on an emergency or non-emergency line that resulted in a good outcome for the patient.

#### The Stork Award

Awarded to *one or a team of two* who successfully assisted in the delivery of a child before medical assistance could arrive.

#### **Rookie of the Year**

Awarded to *one* person with less than one year of service who demonstrates a quick and full understanding of Telecommunicator duties and exhibits an outstanding attitude toward all duties required.

#### **Innovation Award**


Awarded to *one* person who provides a new idea or improvement inside or outside of the communications center that improves on the level of service from his/her agency.




