





FY2021 Funds Usage of the Estimated \$3M


FY22 Funds Usage of the Estimated \$3M

### **Starlink Connectivity Project**

Starlink is a satellite internet constellation operated by SpaceX, providing satellite Internet access coverage to 45 countries. It also aims for global mobile phone service after 2023. SpaceX started launching Starlink satellites in 2019.



On January 4, 2023, around 2:30pm, Starlink was leveraged to deliver the first 911 call using nonterrestrial connectivity in Alabama. Geneva County 911 is INdigital's first site that has successfully used Starlink as an alternate transport medium for call transport. The 911 call was delivered to MEVO.

The benefit of using this commercially available connectivity method is that is gives PSAPs without sufficient network diversity due to location or provider offerings the ability to lessen the likelihood that the PSAP goes without 911 service.

Because of the latency issues associated with any satellite-based network, traditional hosted CHE will not work when using Starlink. Still, call delivery and delivery to MEVO experiences no interruption in service when using satellite internet.




### **ESiNet Trends**

The average call volume per day was 11,866, down from 11,979 the previous reporting period – total calls since the last report was 723,809.




### Average Calls by Hour November 1 - December 31, 2022



The 5:00 a.m. hour was the least busy The 6:00 p.m. hour was the most active




### Average Daily Call Volume November 1 - December 31, 2022








#### **Significant Event Analysis** National Peanut Festival / Active Shooter November 12, 2022



Gunshots erupted at the end of Dothan's signature annual event, leaving one person dead, another wounded and sending terrified spectators ducking for cover.

The shooting happened along the downtown parade route, at the intersection of West Main and Montana streets. A group of people had gotten into a fight, police said, and at least one person produced a gun and fired into the group, hitting two victims.






- Aggregated ECD Boundaries with Anomalies








