 - Have submitted the most recent ECD Annual Certification and Annual Reporting Information to the Examiners

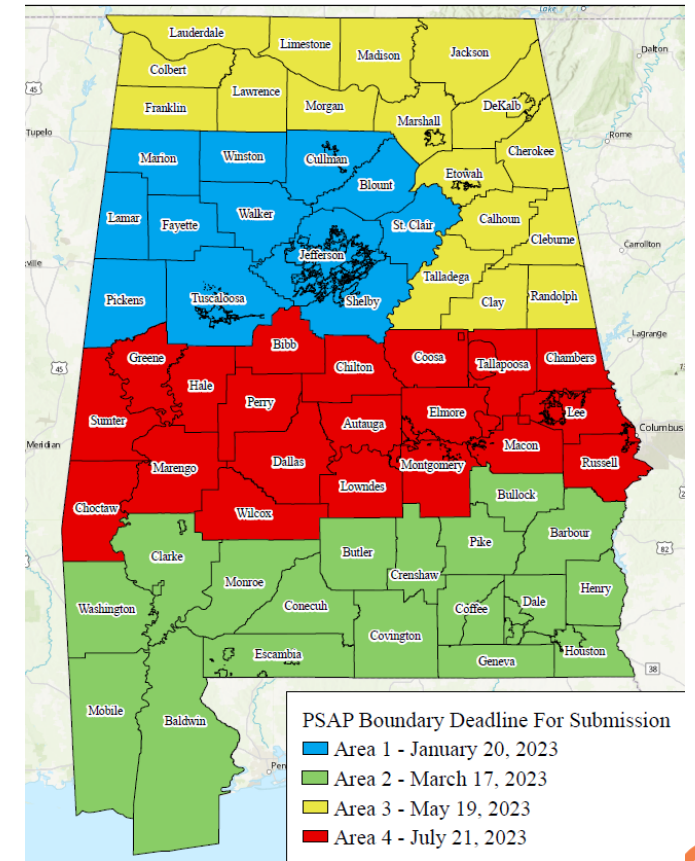
ALEMD Program Update

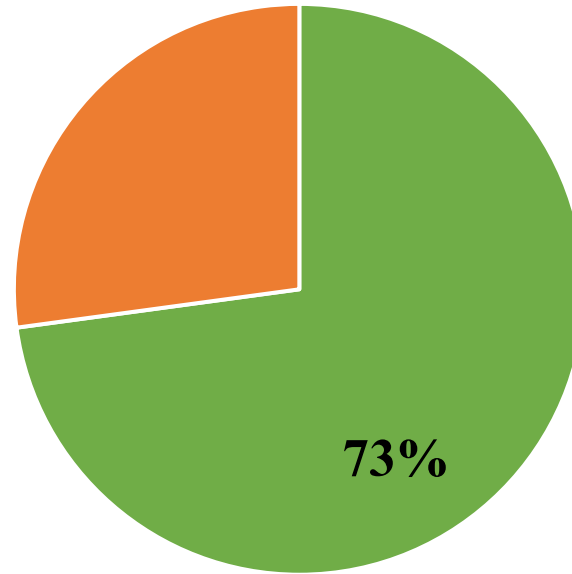

ALPST-1 Certification Program

- 1,103 personnel affiliated with primary PSAPs that are ALPST-1 Certified
 - 937 are earning their CEUs
 - 166 need to complete their reciprocity module within Virtual Academy
- 316 personnel eligible to take Competency Exam (i.e. hire date prior to 07/1/2022)
 - 13 were signed up as of 05/31/2023
 - 303 more are eligible
- 73 personnel need to enroll in board-approved PST Course (i.e hire date after 06/30/2022)
- 22 personnel that we need more information on before we can determine their path forward

3. The AL911 Board will email Virtual Academy with user information
4. VA will create the user information and send over to the AL 911 Board to distribute to the new user(s)
5. AL 911 Board will pull user progress from site when needed

OPTION 2 – PSAPS SIGN-UP USERS

1. AL PSAPs sign up users at <https://www.nena.org/page/tcc>
2. AL PSAPs will enter Promo Code : ALABAMATCC
3. AL PSAPs will enter PSAP's billing information and NENA will generate invoice and send to the PSAP
4. Upon receipt of invoice, PSAP will complete [Request for Payment for PST Certification](#) to the Board. Submissions made by the 10th will be paid out at the end of the month. Anything submitted after the 10th will be paid at the end of the following month.
5. VA generates new user information automatically when enrolled through the NENA TCC site. User information is sent directly to the user's email address. Please note, emails for new user accounts are system generated and may land in SPAM folders. Users should check SPAM folders.
6. VA Tech Support is available 24/7 for all users and admin at 855-227-9119. They can resend user information and reset passwords.
