Dear ECD Director,

In our most recent examination by the Alabama Department of Examiners of Public Accounts, the Examiner found that the calculation being used by the Alabama 9-1-1 Board for its monthly distributions to ECDs did not appear to include all landline 911 charges as required by Code of Alabama 1975 Section 11-98-5.2(b)(1) for fiscal year 2023. As a corrective action to remedy the Examiner's finding, the Board voted to distribute these funds during its regularly scheduled meeting on November 15, 2023. This distribution is based on population using data provided by the Center for Business and Economic Research at the University of Alabama for the fiscal year the funds were collected in. The distribution amounts are broken down by ECD on the following pages. These funds are scheduled to transfer to your account on or about November 30, 2023.
