## PSAP - Leadership

Director can also be a Department Head, Police Chief, Fire Chief, 911 Center Manager, or otherwise. This person is the top authority over the PST's in this PSAP.

Deputy Director can be known by another title, but serves as an administrator for the department.

Operations Manager may also be considered the Communications Department Head for a sheriff's department or police department.

Training Contact is someone who would be in charge of training for the PST's.

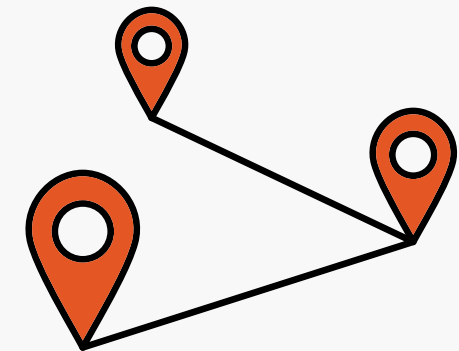

## PST CERTIFICATION REIMBURSEMENT

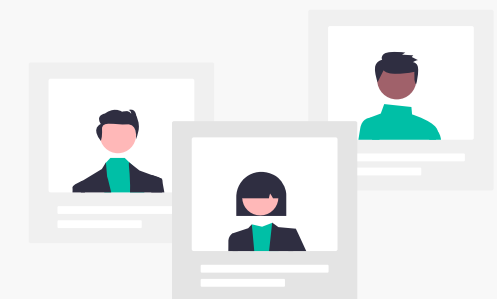
### Request for Payment for PST

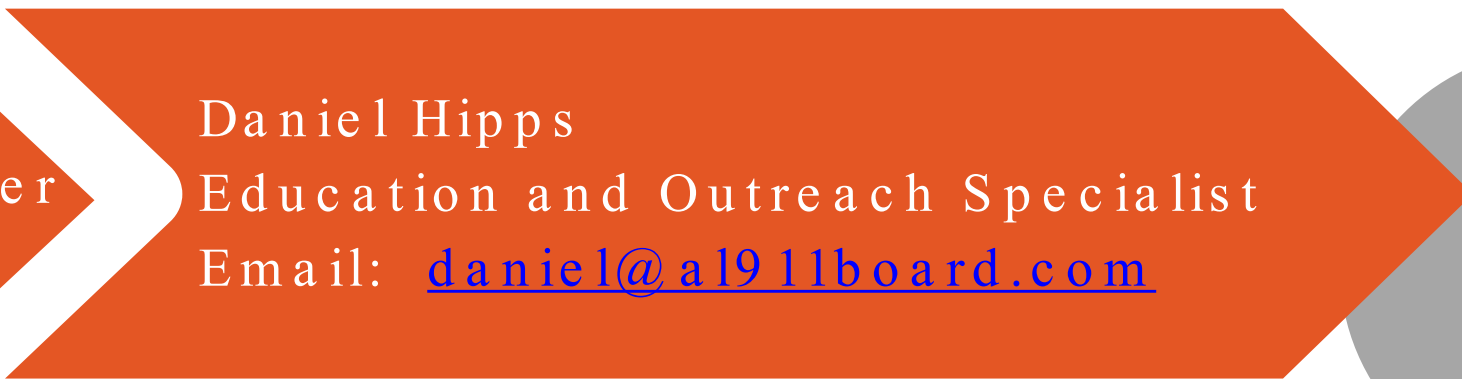
