Dear ECD Director,

Please find included the monthly statement of the distribution of the Alabama 9-1-1 Fund.

The table below represents the 9-1-1 Fund as a whole for collections in the month of February 2024 scheduled for distribution in the month of March 2024. Your District’s portion of these funds will be made available in your account March 15, 2024. One item of note is that this month’s distribution contains an adjustment of your monthly baseline for carriers that began to remit at the most recent surcharge rate of \$2.23. Last month, a very small percentage (or 0.46%) remitted by carriers was from the \$2.23 surcharge; this month 99.52% remitted by carrier was from the \$2.23 surcharge. Additionally, the Department of Revenue deposit for this month’s distribution is still at the \$1.86 rate, which should be their last month at the old rate. We continue to expect these percentages to adjust monthly over the next couple months until all carriers are compliant with the current surcharge. The breakdown can be found on the following pages and there will be only one ACH transaction for the monthly distribution.
