










\$2.23 911 Surcharge Revenues



























Prior Grant Cycles Updates

- **❖** Grant Cycle 7 All projects have been completed.
- **All projects have been completed.**
- ❖ Grant Cycle 9 (+3) 23 of 34 projects have been completed; awaiting additional information about local financial sustainability, per the grant project agreement for 1 other project categorized as Financial Hardship or PST Wage Increase/Staffing.(Note: 34 of 35 accepted as awarded; one declined.)
- ❖ <u>Grant Cycle 10</u> Indefinitely suspended as of September 2024; requires legislative change taking effect to be able to fund grant program. The signing of Act 2025-376 provided the legislative change needed to clarify the statutory authority for the Grant Program. Staff reengaged with the original applicants in June so that Grant Cycle 10 could be presented today for the Board's consideration.


- After re-engagement communications were sent to all 31 applicants, four ECDs withdrew their applications and three ECDs did not respond by September 1, 2025
- 24 ECDs elected to proceed and provided updated pricing information for 33 projects



- 5. Does the Board want there to be a percentage of cost sharing applied to all or any of the project categories awarded for Grant Cycle 10?
















Legacy Cost Reimbursement: Program Year Costs

















INdigital is proud to partner with Prepared to enhance 911 centers with video and MMS.

The busiest day during the reporting period was July 4th with 10,110 calls processed, followed by July 5th with 9,018 calls processed.



As INdigital grows, improvement is made to border connectivity between Alabama and Florida PSAPs. While not all are live, the indicated blue counties are INdigital sites.

As these PSAPs go live on the network, transfers between Alabama and those Florida PSAPs will not have to leave the network, allowing them to transfer with full location information. Along with transferring location information, more accurate call routing will be available through geo-routing. Additionally, the use of MEVO phones, provided by the Alabama 911 Board to some Florida border counties, will no longer be necessary for call delivery.

585-X-4-.09 Additional Distributions To Emergency Communication Districts From The Cost Recovery Fund.

The Board recognizes that it is of utmost importance that each Emergency Communication District (ECD) validly formed and operating within the State of Alabama as of September 30, 2011, at a minimum, be made whole, as contemplated by the passage of Act 2012-293 and adoption of the statewide 911 charges heretofore made.

In the event two or more ECDs have consolidated during the preceding fiscal year or consolidated before a Board decision regarding additional distributions to ECDs in November, then if a distribution is made, the distribution that an ECD would have received prior to consolidation shall be made to the consolidated, surviving ECD.



- o Rule 585-X-4-.06 Withholding Of Funds By Board For Failure To Provide Requested Information
- o (1) In order for the Board to effectively fulfill its statutorily mandated functions, the Board may from time to time request that a voice communication service provider or an Emergency Communication District (ECD) provide certain information and documentation including electronically stored information to the Board.
- o (2) In the event that an ECD fails or refuses to timely or fully and completely provide such requested information or documentation, including electronically stored information, then the Board, at its discretion, may withhold disbursement due the ECD until such information is received by the Board.
- o (3) In the event that the voice communication service provider is a CMRS provider, and the CMRS provider fails or refuses to timely or fully and completely provide such requested information or documentation, including electronically stored information, then the Board, at its discretion, may withhold disbursements from the Cost Recovery Fund to the CMRS provider until such information is received by the Board.

(8) <u>Penalties</u>.

(a) Penalties shall be imposed for Districts that are noncompliant and notice of noncompliance shall be provided to the District by the Board. Upon notice of noncompliance, the following timeframes shall begin.

Non-compliance Timeframes following notification	Percent District Withholding
3 months	25% of monthly distribution
6 months	50% of monthly distribution
9 months	75% of monthly distribution
12 months	100% of monthly distribution

- (b) District withholdings due to noncompliance will be held in escrow until the <u>District</u> becomes compliant. When a District becomes compliant, the monthly distribution will be restored along with any withheld funds on the Board's next monthly distribution.


On March 5, 2024, the Alabama Public Service Commission (Commission), in Docket No. 33429, approved an all-services distributed overlay over the 334 NPA. Cities in the 334 NPA include but are not limited to Montgomery, Dothan, Auburn, Prattville, Phenix City, Enterprise, Opelika, Selma and many other smaller communities. The new 483 NPA will serve the same geographic area currently served by the existing 334 NPA. Additionally, central office (CO) codes in the 334 NPA will be available for assignment only when all assignable prefixes in the 334 NPA have been assigned. The 334-334 NXX will be released as an assignable CO code after the new 483 NPA in-service date.












