

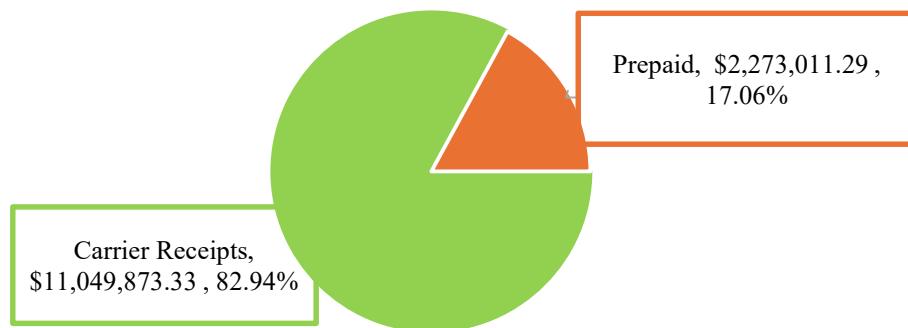

Dear ECD Director,

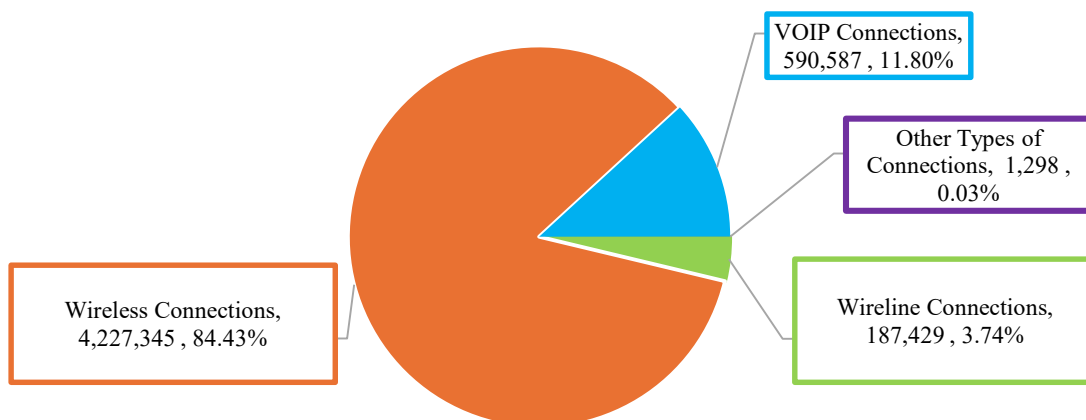
The information below represents the 9-1-1 Fund as a whole for collection of the service charge levied on voice communications service providers and all prepaid wireless 911 charges received from the Department of Revenue in the month of November 2025 scheduled for distribution in the month of December 2025. Your District's portion of these funds will be made available in your account on the dates indicated below. The full monthly distribution calculation can be found on the following pages.

During the previous month, 401 carrier submissions reported 5,006,659 connections remitted through the Board's payment engine and the other revenues were collected by the Department of Revenue and paid over to the Board. The breakdown is as follows:
